DURING THAT PERIOD, MEMBERS ALSO DIRECTED DISTRIBUTIONS OF \$120,250 TO INDIVIDUALLY SELECTED NONPROFIT ORGANIZATIONS. IDAHO WOMEN'S CHARITABLE FOUNDATION (IWCF) EDUCATES MEMBERS ABOUT COMMUNITY NEEDS AND INSPIRES THEM TO POSITIVELY IMPACT THE COMMUNITY THROUGH EDUCATED PHILANTHROPY.
